Hi Pat,

I'm intensely interested in efforts to prevent a full, implemented listing of the Greater sage grouse and how Wyoming's core areas strategy plays a role.

I've been reporting on energy-related issues in Wyoming for the past 15 years, and currently serve as editor-in-chief of [WyoFile.com](http://WyoFile.com), a nonprofit, nonpartisan news organization. Our mission is to go beyond daily headlines and write the full, comprehensive story on issues that really matter to the quality of life in Wyoming.

I started asking questions about the Douglas Core Area back in June after a driving tour of the area. I saw the biggest drilling pads I've ever seen in my life (and I've seen a lot of drilling operations), and I wondered how this was happening in a sage grouse core area. Well, you've probably seen some of the recent reporting on the Chesapeake deal with the Wyoming governor's office, and I have received their document agreement with Chesapeake. But I still have a lot of questions about what this really means to sage grouse in that region of Wyoming and especially to Wyoming's sage grouse core areas strategy that is such an integral cog in really historic efforts to avoid a full-on listing.

I understand that you play an important role in folding the sage grouse core areas strategy into the federal government's oversight and considerations in this question. I'm very eager to visit with you about the Douglas Core Area deal recently struck between Chesapeake and the Wyoming governor's office, and what that might mean to the broader effort to conserve sage grouse habitat and avoid a listing.

I'm in my office all day Wednesday, then covering some legislative hearings in Cheyenne on Thursday and Friday. If you have an opportunity to visit with me in the next few days I would be very grateful.
