Not sure if that was documented anywhere though. This could have been a statement made at a meeting or something mentioned to private landowners along the south side of the bay. Since I have only been to one meeting and not spoken with the landowners to the south, I must have heard this from you. Have you looked at your daily or meeting notes around when the tribe first proposed the farm betw mm2-3? I tried to look on the server, but the cnx is so slow that its taking a long time to load any docs.
