Jennifer and Nathan – If I might make a suggestion relative to our upcoming meeting, it would be wonderful if you could be prepared to educate us about jurisdiction. Specifically, the Tribe needs to better understand just what authority the U.S. Fish and Wildlife Service exerts over the tidelands and public waters of Dungeness Bay. Conversely, we need to also understand where the USFWS authority ends and where the State's authority begins, or where they overlap or just what sharing of authorities might exist. I think it is critical that we all understand this before we leave the meeting.
