On May 1, 2019, Jamestown S'Klallam Tribe raised concerns that verbiage in our February/March comment letters to the US Army Corps of Engineers, Department of Ecology and Clallam County may have been misconstrued by these permitting agencies as a "determination". To ensure that our comments were not misinterpreted, we provided an update to the permitting agencies on May 22, 2019. The update clearly stated that our comments are not intended to provide a determination and that we do not have any regulatory authority to provide a determination in this process. Given that clarification has been provided to eliminate misinterpretation of our February/March comments as a determination, withdrawal of the letters does not seem necessary.

Thank you for further ensuring that our intent is not misinterpreted.
