Just received this notification of public notice for the Jamestown S'Klallam aquaculture permit proposal for the tidelands within the boundary of Dungeness NWR. I have asked ACE for the complete permit application, so we can get a better understanding of their proposal.

Using this summary, it looks like they are requesting a maximum of 80,000 on-bottom-bags on 20 acres and on-beach methods used on the rest of the 34 acres.

This application would seem to create many of the same concerns as the original application provided to the County, namely:

- 14-15 month rotation would create a need to access the site for installation/seeding, harvest, and/or maintenance during the timeframe that the area is closed to public uses to reduce impacts to wintering waterfowl and shorebirds.
- There is no description as to how many people would need to access the site during different stages of its development, or how long they would need to stay.
- Access during low tides during the winter would necessitate night time work and require the use of lights which would be very disturbing to loafing/feeding/roosting shorebirds and waterfowl.
- There is no discussion of alternate lease areas.

It seems that with minor tweaking we could probably use the same comment letter that was provided to the County. I don't think we would need to add any new concepts, except for adding a sentence about the possibility of looking at other sites within their "historic shellfish harvesting areas, which includes Dungeness and Sequim Bays" and offering the Cline Tracts and/or Dawley tidelands for this use. If we are able to see the full application, we may be able to pare down our response if some of our initial questions were answered (e.g., frosting).
