Cynthia and Shaun,

A few updates on both the self-governance and oystering fronts:

Self-Governance

- Our negotiating team met with the Tribe last Friday (Jennifer Brown-Scott, Frank Wilson, and myself were in person, Christine called in from the Islands). We talked through the IFFs that the Service has identified thus far, as well as a bare-bones draft of an AFA that the Tribe provides just in advance of the meeting. As for the IFFs, Christine did a great

job walking through the CCP process (one of the IFFs), as it is evident that the Tribe has interest in amending the current CCP to add emphasis to protection of cultural resources. Overall, the meeting went well - we were able to clarify a lot about our processes, and there was minimal debate.

- Next steps: We are working on providing response to their draft AFA, including putting details and performance standards around the activities they propose to manage. We are starting with one example activity, to ensure both parties are on the same page. The next meeting with the Tribe on self-governance is November 28.

## Oystering

- Just before the meeting last week, we received the attached letter from Washington DNR. This letter was a surprise and could be viewed as inconsistent with the past position of the State. However, it does align in some ways with the recent SOL memo.
- During the meeting with the Tribe last Friday, we did not discuss the oystering proposal, except in passing.
- I had the chance to talk with Martha and Wendi regarding the "divestiture" option.
- Next steps: A meeting has been scheduled on October 24 with us, Martha, Wendi, SOL (HQ and Regional), AS FWP, and AS IA. The goal is to get everyone on the same page regarding options before meeting with the Tribe to discuss this topic on Friday, October 28.
