Hi Gerry,

Conservation efforts are evaluated in listing decisions.

Section 4(b)(1)(a) of the ESA requires the service to take into account "those efforts, if any, being made by any state or foreign nation or political entity ..., to protect such species, whether by predator control, protection of habitat and food supply, or other conservation practices, within any area under its jurisdiction or the high seas"

and the mission statement which is to "working with others to preserve, protect and enhance fish, wildlife, and plants for their continued benefit of the American people".

I don't know of any other policy off hand.

Hope this helps.
