This posting will be referred to under Request for Quotation (RFQ) Number F16PS01288. This RFQ falls under procedures in FAR Parts 12 and 13. The North American Industrial Classification System (NAICS) number is 541690, Other Scientific and Technical Consulting Services and the business size standard is \$15 million. This requirement is set-aside for small business. This announcement constitutes the Government's only official notice of this procurement. The Government does not intend to pay for any information provided under this synopsis. Award will be made to the offerer that provides the best value to the government.

Interested contractors shall submit past performance with their quote that shows successful completion of similar projects. Past performance submitted shall not exceed 5 pages. Pertinent projects should demonstrate experience and familiarity with the following elements:

- a. The laws and policies governing the Department of the Interior and Service including the National Wildlife Refuge System;
- b. Offshore island ecosystems;
- c. Natural resources management;
- d. Rodent eradication from islands;
- e. Rodenticide use including federal and California environmental compliance regulations;
- f. Other environmental compliance requirements including preparation of environmental compliance permit applications;
- g. Maintenance and compilation of a NEPA administrative record;
- h. Organizing meetings and preparing meeting agendas, minutes, presentations, and other materials; and
- i. Working in a diverse group with individuals from multiple federal, state, and private organizations.
