Good afternoon,

I was concerned about the SpaceX share this morning that I understood ES as having responded to a media inquiry with a statement concerning the recent SpaceX engine test – I was unfamiliar with our folks responding directly to media and know that they always work closely with OC.

I committed to follow up with Dawn Gardiner, and she and Chuck have both confirmed that they have NOT communicated with media and haven't issued a statement to media. They have responded to some questions from OC concerning SpaceX. ES always relies on and welcomes OC's expertise.

The RDT encourages cross-program communication and coordination, and our ES folks were reaching out to Mig Birds staff to coordinate and bring them more fully into the SpaceX discussions. I'm sure we all appreciate this coordination. Dawn's forwarded message explains the detail of the exchange. We certainly appreciate Mig Birds' expertise and assistance in a complicated issue.

Hope this clears up any confusion, especially as Amy heads south. Jonna
