If you have few minutes today or Monday, we would like to chat about SpaceX's current launch plans. We believe they are currently targeting April 7th or 8th. Those dates appear to be restricted in the PEA due to the Easter holiday. If all other pieces fall into place in time to support a launch that weekend (which is possible but not certain at this point), we believe SpaceX will attempt to seek some relief from those restrictions or try to propose their interpretation of them.
