I asked Mary to write up a summary of where things are, please see below:

The version of the most current draft BA I received on 9/18/2023 was in word format with track changes so we could see the changes they made and with our original comments along the side with their responses. I spoke with Amy Hanson yesterday and she stated they expected us to have further comments on this one and there would be another version coming out. They are looking at a something that was analyzed and evaluating whether it was

complete or not, and whether it was appropriate to include in the BA. They did send the Appendices I had requested be included with this version and the figure we discussed was revised. I have not completed my review of this version I am doing that today to be prepared for tomorrow's call.

I have not received the Mishap Summary with the 63 corrective actions. Chris and I were trying to get the name of the engineer or a contact to try and request the report again because at the end of the meeting I failed to get his name and provide him my email address. If Amy could ask Gwynne for it it would be great. FAA has told Dawn and I that they will discuss the Mishap Summary with us on tomorrow's call. I don't know if that means they will provide us with a written copy or just verbally discuss it with us.
